



#### TERMS AND CONDITIONS OF ALER'S NEWS MONITORING SERVICE

## **SCOPE**

ALER's News Monitoring Service (hereinafter called "Service") covers Press and online Media articles regarding renewable energies within the seven priority countries of ALER (Angola, Cape Verde, Guinea Bissau, Equatorial Guinea, Mozambique, São Tomé and Príncipe and East Timor). Articles about ALER are also monitoring in the Portuguese Media.

In a footnote of every news monitoring email, it is underlined that the location of the articles refers to the origin country of the Media monitored, which may be different from the country referred to in the article.

## **FREQUENCY**

The news monitoring emails are sent every Mondays and Thursdays during the morning. This periodicity might be adapted in the future according to the availability of the news.

## **DISCLOSURE**

News monitoring emails, like all official communications from ALER, will only be sent to the ALER's Member representative and to the Service sponsors.

Nonetheless, other internal employees from Members and Service sponsors can also receive the information. If that is the case, please inform us of the email addresses to be added to the list to geral@aler-renovaveis.org.

Since the Service is exclusive to Members, it is not allowed to forward, publish, copy, use or distribute information to external contacts, even if they are your partners, external advisers, members, etc. We thank you in advance for your understanding about this issue.
